## 2. Pay Application No. 6, Tri City Electric

Motion by Zearley, second by Siech to approve pay application No. 6, to Tri City Electric, in the amount of \$36,337.77, for the substation project. Following the roll call vote the motion passed unanimously.

## 3. One-Time Sewer, Water Adjustment, 1200 North Avenue

Motion by Fry, second by Spear to approve the one-time water and sewer adjustment for 1200 North Avenue, reducing the water and sewer portion of the bill to \$16.21 each, resulting in a total reduction of \$150.54. Following the roll call vote the motion passed unanimously.

#### 4. Cellular Phone Service, U.S. Cellular, Verizon WSCA Contract

Nosbisch said that by moving to the Verizon WSCA Government Contract the monthly savings could be as much as \$300.00. Motion by Siech, second by Anderson to approve converting the City's cell service from U.S. Cellular to Verizon's WSCA government contract. Following the roll call vote the motion passed unanimously.

## 5. Contract Knuth Law Office, Real Estate Transition

Motion by Zearley, second by Spear to approve the recommendation of the City's attorney and hire Knuth Law Office to represent the City in regards to a real estate transaction, with a contract not to exceed \$5,000.00. Following the roll call vote the motion passed unanimously.

# 6. Street Closure, 107 Meadow Lane

Motion by Spear, second by Zearley to approve the request from Jason Harmon to close the Meadow Lane cul-de-sac for a July 4<sup>th</sup> celebration, which has been approved by Police Chief Holub. Following the roll call vote the motion passed unanimously.

## **Discussion Items (No Action)**

1. Zero Tolerance Policy, JKFAC

There have been issues with an individual intentionally fighting and causing injuries at the James Kennedy Family Aquatic Center. Because of this the person's privileges have been revoked for the year.

# 2. July 4<sup>th</sup> Update

Staff has been working on the areas for the parking and seating for the fireworks. Nosbisch thanked the community for the donations for the July 4<sup>th</sup> celebration. Nosbisch added that these changes were necessary because of safety issues and insurance coverage.

## **Manager's Report**

Hopes to have the scope of services identified within the next two weeks at the James Kennedy Family Aquatic Center.

There were more backups with the last rain and in places that we didn't see the last storm. Lines will be televised to be sure there is no system damage.

New light poles have been installed at the park. Electric Department will be working to replace the dirt in the trench that was lost in the last storm.

Cedar County has agreed to participate in the WENS Program with City and will be signing a 28E Agreement. With all of Cedar County onboard it will be a savings of \$400.00 to the City.
